<b>Rental Income</b>	Details of any rental income received during the year and any expenses incurred including loan/mortgage interest
<b>National Savings</b>	Annual interest details - ensure pass books are up to date
<b>Interest from Banks/Building Societies</b>	Tax year-end summaries or up to date pass books
<b>Other Interest Received</b>	Full details including any tax certificates
<b>Dividends</b>	Details of the net dividend received and the tax credit Please provide all dividend Tax Vouchers if possible
<b>Stock Dividends / Unit Trusts</b>	All Tax Vouchers / Summaries
<b>Foreign Investment Income</b>	All Tax Vouchers / Summaries
<b>Income from Trusts and Estates</b>	Forms R185 and R185E
<b>Maintenance Payments / Receipts</b>	Details of any changes
<b>Other Income</b>	Commissions, casual earnings
<b>Mortgages or Other Loans</b>	Interest Certificates (MIRAS 5) for any relevant loans
<b>Private Medical Insurance</b>	Tax Certificate (if applicable)
<b>Pension Contributions</b>	Details of any changes, new or ceased policies
<b>Deeds of Covenant/Gift Aid</b>	Details of any changes, new or ceased arrangements
<b>Capital Gains</b>	Details of any sales of shares, land, property etc Please include details of original purchase date and cost if possible
<b>Personal Allowances</b>	Details and dates of any changes
<b>Children Under 18</b>	Name of youngest child living with you and their date of birth and the name and NI number of other parent
<b>Gifts</b>	Details of any gifts made during the year

If you have opened any new Bank or Building Society accounts please provide us with details of the name of the Bank/Society, the account number and the date the account was opened - even where no interest has been credited during the Tax Year.

Similarly, could you please provide full details of any new pension policies or loans including the policy number and the frequency and amount of the contributions.

If you have purchased any new shares/securities, land or buildings then please provide us with details of the cost and date of acquisition for future reference.
